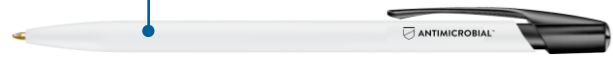
BIC® Media Clic BGuard™ - classified as a biocidal product - was designed and manufactured to **act against** bacteria, viruses and fungi.
